MESSAGE FROM THE PRESIDENT

November 29, 2017

Greetings Members,

Sent with this message is a revised notice and agenda for our annual meeting along with other documents. Since the delivery of the original notice, several procedural and other questions have been raised. All deserve to be addressed. Accordingly, as President, I made inquiry, considered the facts, and made the following determinations:

- 1) With regard to proxy voting: In accordance with the lawful and well-settled practice that enables proxies of members of associations such as ours to act in their stead, a proxy may to attend the meeting, vote at the meeting, and speak at the meeting on behalf of the member.
 - a. Section 33-1072(b) of Part VI (C) of the Connecticut Revised Nonstock Corporation Act (the "Act") states, "A member entitled to vote by proxy or his agent or attorney-in-fact may appoint a proxy **to vote or otherwise act** for the member...." This law indicates that a proxy appointed by a member for a homeowners' association meeting in Connecticut may attend, vote, speak, and even make motions.
- 2) With regard to propositions regarding two classes of membership: The propositions regarding multiple classes of membership will not be noticed or presented for vote, and will be struck from the records of the Association as they are in violation of Connecticut law:
 - a. The Association was created under the provisions of the Act, and the Act remains the controlling statute for our Certificate of Incorporation.
 - b. The proposals regarding different treatment of members whose properties are adjacent to the pond from those members whose properties are not immediately adjacent to the pond would create two classes of members, *i.e.*, so-called abutters and nonabutters.

- c. Section 33-1055 of Part VI (A) of the Act states that, "If the corporation has one or more classes of members, the designation of such class or classes **shall be set forth in the certificate of incorporation...**"
- d. Our Certificate of Incorporation makes no mention whatsoever of classes of members and any attempt to create classes of members by way of a bylaw provision would, therefore:
 - i. violate the Act,
 - ii. be wholly unenforceable, and
 - iii. subject the Association to a lawsuit.
- e. Accordingly, the proposals regarding two classes of members are out of order, will not be presented to the membership, and any reference to them shall be struck from the records of the Association. On this topic it should be noted that our Certificate of Incorporation states that one of the purposes of the Association is to take title to the open spaces and the pond **for the benefit** of the owners of lots 1 though 61 and provide for the maintenance and upkeep thereof. Without more, the Certificate of Incorporation treats all members as sharing benefits and obligations without difference or discrimination.
- 3) With regard to anonymous email communications with Board members: All email communications by association members to members of the Board must bear an email address that can be ascribed to the member sending the communication (or contain the name of the sender in the body of the message), lest they be promptly discarded. Without certainty of authorship, anonymous communications could provide a prankster or malcontent the means to detract from the open and public nature of the democratic principles on which our Association is governed.
